

TERMS AND CONDITIONS

This ticket is issued on behalf of the Organization (PRH d.o.o.) responsible for the event and is subject to the following terms and conditions:

On 21.6.2021 public cultural events are permitted, subject to the following limitations:

- the number of end users both in enclosed spaces and outdoors air is limited to 75% of seating capacity,
- outdoors, there must be at least 1-metre distance between seating positions, and at least 1.5-metre distance between end-users who are not seated,
- end users and performers must meet the RVT condition*.

Compliance with the (RVT condition) recovered-vaccinated-tested-requirements means that the person can produce one of the following certificates:

- proof of a negative PCR-test or rapid antigen test (RAT) for the presence of SARS-CoV-2, provided that less than 48 hours have passed since the swab was taken;
- proof of a COVID-19 vaccination demonstrating that:
 - at least seven days have elapsed since receiving the second dose of the Comirnaty vaccine produced by Biontech/Pfizer or at least 14 days have elapsed since receiving the second dose of the COVID-19 Vaccine produced by Moderna, the Sputnik V vaccine produced by Russia's Gamaleya National Centre of Epidemiology and Microbiology, the CoronaVac vaccine produced by Sinovac Biotech or the COVID-19 Vaccine produced by Sinopharm,
 - at least 21 days have elapsed since receiving the first dose of the Vaxzevria (COVID-19 Vaccine) produced by AstraZeneca or the Covishield vaccine produced by the Serum Institute of India/AstraZeneca,
 - at least 14 days have elapsed since vaccination with the Janssen COVID-19 Vaccine produced by Johnson and Johnson/Janssen-Cilag;
- proof of a positive PCR test result that is older than 10 days, unless a doctor determines otherwise, but not older than six months, or
- a medical certificate confirming that the person has recovered from COVID-19 and that less than six months have elapsed since the onset of symptoms, or
- proof of a positive PCR test result that is older than 10 days, unless a doctor determines otherwise, but not older than six months, or a medical certificate confirming that the person has recovered from COVID-19 and that less than six months have elapsed since the onset of symptoms and that, within no more than eight months since a positive PCR test result or from the onset of symptoms, the person has been vaccinated with at least one dose of a vaccine recognised in Slovenia. Such person is considered protected as of the day of vaccination.

Persons younger than **18 years** who attend the festival with a close family member or guardian without a test for the presence of SARS-CoV-2 or other certificates listed in the proposed ordinance.

Like we mentioned before, The Slovenian Government is enrolling an event insurance scheme from August 1st 2021, which means outdoor events can happen with 100% capacity - no distancing, no masks - from August on. The only measure that will still be in play is the RVT condition to enter the festival.

We will update the situation promptly here and via social media.

The event may be recorded live for use in the forum of sound recordings, television videotapes and other means of audio and audiovisual reproductions, now known to be invented. The purchaser of this ticket consents to participate in the said recordings and grants all necessary consents for Performers Protection Act.

We regret that tickets cannot be exchanged or refunded after purchase, statutory rights not affected. None of the promoters, performers, sponsors, venue or ticket outlets shall be responsible in any manner whatsoever for any property loss, destruction or theft which shall be entirely at the Holders own risk save where and to the extent that same arises from breach of contract (not due to an event of unforeseen circumstances) by, or the negligent act or omission of, such promoters, performers, sponsors, venue or ticket outlets.

Upon entry to the festival grounds, your ticket will be exchanged for a festival wristband, which will allow you to exit and enter the festival grounds without limitations. From that moment on, the entry ticket is no longer valid. The holder of this ticket declares that he/she is informed about the rules, which PRH d.o.o. has posted on festival website and that he/she fully accepts those rules. If the holder does not adhere to the rules, posted on an event website or abuses the ticket or the event wristband in any way, he/she will be removed and banned from the venue and/or handed over to the competent authorities.

PRH d.o.o. reserves the right to modify parts of the artist billing in line with the event concept. In case of such modification, the entry ticket is equally valid, can not be returned and no additional fee will be requested. Date of the Punk Rock Camp festival is subject to change without prior notice. All possible changes will be announced on official social media, so please check it regularly.

PRH d.o.o. reserves the right to add extra shows and/or additional days (like Warm Up Show or Early Arrival) to the festival schedule. This festival ticket includes camping and is only valid for the specified dates, does not cover such additions and in that case up-charges may appear. Both Early Arrival and Warmup Show will be charged extra and are payable onsite at your arrival.

In case the event is cancelled (excluding Force Majeure) , the ticket can be returned at the shop, where it was bought within 30 days period and under the rules and conditions of the shop, where the ticket was bought. In case of event cancellation, changes of dates or any

other changes, regarding the event, the additional expenses (public or organized transportation, private travel arrangements, accommodations and/or others) will not be reimbursed.

In case of cancellation due to restrictions regarding Covid 19, tickets will be fully refunded.

Force Majeure: In the case of circumstances beyond Promoter's control such as war, civil or political unrest, actions and orders from the authorities, strikes, catastrophes, epidemics, pandemics or other severe damages or highly unexpected factors, Promoter of Punk Rock Camp festival may cancel or may be forced to cancel the festival. In such a case all the funds received including (but not limited to) money from sold tickets, parking, additional fees, upgrades, sponsorship, donations and similar will not be refunded.

PRH d.o.o. reserves the right to refuse admittance to the ground or any part of the ground or to remove any person or persons from the ground for reasons of public safety, overcrowding or otherwise as the Organizers will have no liability for any damage or loss whether consequential or otherwise save that the Organization will refund to the owner of a valid ticket the face value of the ticket.

Ticket Holder is responsible for care of tickets after purchase. Sellers/agents are not responsible for damage or loss of ticket. Admission by full ticket only - no re-admission unless by prior arrangement.

BUY YOUR TICKETS FROM AUTHORISED OUTLETS ONLY, THOSE SEEKING TO GAIN ADMISSION USING A COUNTERFEIT TICKET WILL BE PROSECUTED.

Holder assumes all risk of injury and all responsibility for property loss, destruction or theft and releases promoters, performers, sponsors, venue, ticket outlets and their employees from any liability thereafter, save that nothing in this clause shall exclude or purport to exclude promoters, performers, sponsors, venue, ticket outlets and their employee's liability to the Holder for (a) any personal injury or death caused by any such party's negligence or (b) fraudulent acts.

IMPORTANT! Both stages do not have mojo barriers. If you choose to stage dive, you do it at your own risk! Please make sure everything you do in the pit, you do responsibly for yourself and everyone around you. When you climb on the stage dive platform, please DO NOT stay on it for longer than the time you find people to catch you safely. Do not dance on it or do selfies and DO NOT enter the artist area of the stage at any time (unless approved by the band). First 10 rows of the pit might be overcrowded. If you feel unsafe, please move back, where there's enough room to move. And please take care of each other. In case of any kind of injuries or feeling weak, please visit the first aid area immediately!

Before entering, all patrons will be subject to a search in a manner permissible under the law. In the interests of public safety where offensive materials are found, anyone refusing to consent to personal search will be denied entry.

The making of a recording of a performer's performance without their prior consent in writing is a criminal offence. The use of professional cameras or recording equipment is prohibited.

Event will take place Rain or Shine. Tickets cannot be used for promotional purposes unless permitted by the Organizer. Tickets may not be resold for more than face value.
